SUBJECT: Finance and General Services – Conduct Public Hearing on Airport Landing Fees, Adopt <u>ORDINANCE</u> Amending Torrance Municipal Code (TMC) Pertaining to Airport Landing Fees, Adopt <u>RESOLUTION</u> Establishing Airport Landing Fee Rate, and Approve Ordinance Summary for Publication. RECOMMENDATION

Recommendation of the Finance Director and General Services Director that City Council:

- 1) Conduct public hearing on airport landing fees; and
- Adopt an <u>ORDINANCE</u> amending Torrance Municipal Code (TMC) Section 51.2.30 entitled "Definition of Revenue Operations" and Section 51.2.31 entitled "Fee for Revenue Operations," and repealing Section 51.2.32 entitled "Refusal for Clearance"; and
- 3) Adopt a **RESOLUTION** establishing an airport landing fee rate; and
- 4) Approve an Ordinance Summary for publication.

FUNDING

None required.

BACKGROUND/ANALYSIS

On July 25, 2023, City Council approved the implementation of landing fees at the Torrance Municipal Airport (Airport). To implement landing fees at the Airport, a public hearing is required for the adoption of an ordinance to amend the TMC and adoption of a resolution to officially set the landing fee rate.

During the July 25, 2023 meeting, City Council requested that certain restrictions and exemptions be placed on the applicability of landing fees as outlined below:

- Landing fees would apply to transient aircraft; and,
- Landing fees would apply to flight schools with three or more aircraft in their fleet; and,
- An exemption would be granted for military, public safety, medical, and Torrance-based rotary wing aircraft manufacturers.

Although staff prepared an ordinance consistent with this approach (Attachment A), staff is seeking City Council direction on the preferred language of the ordinance for adoption. In consultation with the City Attorney's Office, staff prepared an alternative ordinance for Council's consideration to apply consistently across all aircraft users. In the alternative ordinance (Attachment C), landing fees would apply to all aircraft except for military, public safety, and medical aircraft landings at the Airport.

Additionally, staff prepared a resolution (Attachment E) to formally establish the landing fee, which sets the rate at \$3.00 per 1,000 pounds, for all aircraft weights, with a minimum charge of \$6.00 per landing. Upon approval, staff will enter into a contract services agreement (RFP B2023-02) with Vector Airport Systems to manage the billing and administration services for the implementation of this new landing fee.

Accordingly, the Finance Director and General Services Director recommend that City Council conduct a public hearing on airport landing fees, adopt an ordinance amending the TMC pertaining to Airport Landing Fees, adopt a resolution establishing a landing fee rate, and approve the ordinance summary for publication (Attachment F).

The City Council of the City of Torrance does hereby ordain as follows:

SECTION 1

That Section 51.2.30 and Section 51.2.31 of the Torrance Municipal Code is amended in its entirety and Section 51.2.32 is repealed to read as follows:

"51.2.30 DEFINITION OF LANDING FEES

a) A landing fee shall be charged to any individual or entity landing an aircraft as a transient at Torrance Airport and also include any individual or entity operating a flight school based at Torrance Airport with three (3) or more aircraft in its fleet. Military, public safety, medical, and Torrance-based rotary wing aircraft manufacturers shall be exempt from landing fees.

b) Aircraft shall include both fixed wing and rotary wing aircraft for purposes of assessing landing fees.

c) The Airport Manager shall determine in each case whether or not a landing has taken place that qualifies for being charged a landing fee within the meaning of this Section.

51.2.31 IMPLEMENTATION OF LANDING FEES

Any landing at the Airport, as defined in Section 51.2.30, shall pay to the City for each such landing a fee. This fee amount shall be established by resolution of the City Council."

SECTION 2

Any provisions of the Torrance Municipal Code, or appendices, or any other ordinances of the City inconsistent with this ordinance to the extent of such inconsistencies and no further, are hereby repealed.

SECTION 3

The City Council of the City of Torrance does hereby ordain as follows:

That Section 51.2.30 and Section 51.2.31 of the Torrance Municipal Code is amended in its entirety and Section 51.2.32 is repealed to read as follows:

"51.2.30 DEFINITION OF DEFINITION OF REVENUE OPERATIONSLANDING FEES

a) A revenue landing fee operation (either landing or take off or both) shall mean be charged to any individual or entity landing an aircraft as a transient at Torrance Airport and also include any individual or entity operating a flight school based at Torrance Airport with three (3) or more aircraft in its fleet. for hire operation by a person operating an aircraft at the Airport who does not have a written agreement therefor with the City; and shall include a departure or an arrival regardless of the final destination or origin of the flight wherein the operator is performing a service for a fee. Military, public safety, medical, and Torrance-based rotary wing aircraft manufacturers shall be exempt from landing fees.

b) An operation for the purpose of ferrying, testing, training, or inspection and operations made by aircraft carrying employees, agents, or guests of the person owning the aircraft shall not be deemed a revenue operation within the meaning of this Section Aircraft shall include both fixed wing and rotary wing aircraft for purposes of assessing landing fees.

c) The Airport Manager shall determine in each case whether or not <u>a landing has</u> <u>taken place that an operation is a revenue operationgualifies for being charged a</u> <u>landing fee</u> within the meaning of this Section.

51.2.31 IMPLEMENTATION OF FEE FOR REVENUE OPERATIONSLANDING FEES

Any person conducting a revenue operationlanding -at the Airport, as defined in Section 51.2.30, shall pay to the City for each such landing or take off a fee. This fee amount shall be established by resolution of the City Council." -in accordance with the following schedule:

51.2.32 REFUSAL OF CLEARANCE

The Airport Manager may refuse clearance to any aircraft until all charges for storage, service rendered to it by the City, and fees for revenue operation have been paid."



EXHIBIT B

FINDINGS FOR ESTABLISHING LANDING FEES AT THE TORRANCE MUNICIPAL AIRPORT – ZAMPERINI FIELD

- 1. The following findings are true and correct and made part of this Resolution.
- The City of Torrance's adoption of landing fees at Torrance Municipal Airport Zamperini Field is pursuant to its proper exercise of authority granted under Section 1305(a) of the Airline Deregulation Act of 1978.
- 3. The City of Torrance's adoption of landing fees is consistent and in compliance with the FAA's Policy Regarding Airport Rates and Charges.
- 4. The landing fees, as adopted, are necessary to offset the City's costs incurred in maintaining and operating the airport facilities. The fees are non-excessive in comparison with the airport facilities provided.
- 5. The landing fees set forth in Exhibit A are fair and reasonable because they are fixed according to a fair and practical standard based on the per-operation charge and a weight-based charge and comply with 49 U.S.C. 40116.
- 6. The landing fees are non-discriminatory because they are reasonable and fair and will be applied to each aircraft over 1,000 pounds.
